- 4. Paul Kilian, Chairman of the COS Vestry Nomination Committee, presented the Vestry slate candidates for 2023.

Following a call for nominations from the floor of which were none, the Nomination Slate presented by the Nominating Committee was approved by an acclamation vote

- 5. Rector Jeffery Thornberg appointed John Vandercook as Senior Warden
- 6. The Gospel was read by Deacon Bill Doulos
- 7. Rector's Address (highlights) The Rev. Jeff D. S. Thornberg
  - a. "Loyalty and Service; Change of mindset to develop a healthy collaboration and unification leads to forgiveness
  - b. The COS Music Program Hiring a Director of Music
  - c. Children's Program SPARK (Speech and Reading Kids) a children's ministry lead by Hannah Riley for all of the parish and community children
  - d. Jean Dillingham, COS Administrator, has developed a strong church administrative staff
  - e. Chinese Ministry is expanding into the community with help though Dustin Seo's Laos program
  - f. The church continues to move forward into the future as a community, be open to where we are now, and remain together though praying, talking, dialoging and be open to new ideas; we also need to listen and hear each other to build trust within our church family.
  - g. With Bill Doulos' retirement in June 2023 Rev Tim Hartley will transition into the Director of Transitional Housing position

  - a. The Vestry hopes to grow our COS community with outreach in the neighborhood and community
  - b. To present an honest transparent budget
  - c. As Properties Chairman he thanked the parish for their support of the Capital Campaign for the support and donation towards the repair and maintenance of the COS campus
- 9. Treasurer's Report (highlights) David Waller
  - a. Thank you Will Dumain for all the years of service as COS's Treasurer
  - b. Thank you to Anh Nguyen for her assistance to the Treasurer
  - c. This has been a difficult year for the budget the stock market was down as was pledge collection amounts resulting in loss of endowment and pledge income to 2022 Budget
  - d. 2023 Budget has been approved by the Finance Committee and Vestry with a deficient budget
  - e. Gabe and Taylor Vazquez-Reyes' tasks will be redistributed among the staff and a part-time IT person will be hired, to reduce expenses
  - f. Renters in COS properties will now pay their own utilities
  - g. A Reserve Study was done to evaluate buildings and required maintenance for the buildings

- h. Staff members have been asked to remain within their budget and to come to administration if they go over their budget
- 10. Junior Warden's Report (highlights) Kit Shenk
  - a. The Junior Warden's position represents the congregation and thus is their sounding board and advocate. Please contact Kit if you have an issue or concern within the parish
  - b. Highlights of the year were ordination of the Rev Tim Hartley and the participation of Presiding Bishop Michael Curry in the ordination
- 11. Gratitude and Recognition/New Business
  - a. Thank you to Deacon Bill Doulos and the Rev Tim Hartley for continued assistance with the clergy duties of the parish and parish life
  - b. A discernment committee is being formed to evaluate the relationship between OSC and COS with Dennis Duling and Brenda Maceo agreeing to be members of the committee
  - c. A Finance Forum will be held March 5, 2023 to discussed the 2023 COS Budget
  - d. A Music Committee will be formed to hire the Director of Music and will include the choir
  - e. Thank you to Paul Kilian for heading the Music search committee
  - f. Hannah Riley's duties are expanding and her program position has been changed to Associate for Congregational Life. A part-time Administrative Assistant will be hired to help with administrative tasks
  - g. Thank you to John Ballance and Von Vine and the Vine Family for the improved streaming capabilities
  - h. Vera Hoalim has been hired part-time as an assistant accountant
  - i. Thank you to Rex Botengan for his weekly Hospitality table with coffee and cookies
  - j. Thank you to the two David Hans for their weekly support of the Chinese and English streaming of the services
  - k. Thank you to Samantha Sun for work with Chinese Parish Committee
